

FORWARD NOT BACK

Wall Street and corporate CEOs destroyed American jobs and now have the highest profits and cash reserves in history. Yet, they are asking Gov. Christie and the legislature for new giveaways.

New Jersey is the most densely populated state in the nation and we have the greatest number of hazardous facilities per square mile – which is just one reason why our state safeguards to protect health, public safety, air and water quality, and jobs are often stronger than federal standards.

Throughout our history, the NJ legislature has passed laws setting broad policy to protect the public interest. Scientists and other public interest professionals have then used the best evidence and research to develop detailed safeguards for all corporations to follow.

But now Assembly Bill 2486 (Burzichelli/Rumana) and Senate Bill 1986 (Van Drew/Oroho) – backed by corporate CEOs and Wall Street – would:

Block state agencies from issuing new safeguards stronger than federal standards unless the 120 members of the legislature had debated and voted on every word – meaning that decisions about our

fundamental safeguards would be determined by political infighting, gridlock, and lobbyists' influence instead of facts and evidence.

- **Undo longstanding safeguards** as they come up for renewal and revision and thus could be considered “new” standards banned by this bill.
- **Lead to millions of dollars worth of litigation** over how the bill is interpreted.

Just some of the many NJ safeguards threatened by this bill concern:

- Oil spills, toxic contaminants in drinking water, and ocean dumping.
- Nuclear and chemical plant accidents or attacks.
- Workplace hazards.
- Layoffs by corporations after they took tax subsidies to provide jobs.
- Students with disabilities.
- Food and toy safety.
- Lead poisoning of children and building occupants.
- Quality standards for seeds and agriculture.

2. **Pass a resolution and sign petitions opposing A2486/S1986. Contact the NJ Work Environment Council for a model resolution, petitions, and how to get involved.**
3. **Tell Gov. Christie and our legislators that we need green jobs and stronger safeguards, not new giveaways to Wall Street and corporate CEOs.**
